The Chicago Fury AAA Hockey Club is please to announce the dates for the **2nd Annual U16 & Bantam Major Labor Day Face-Off Invitational** to be held at the Arctic Ice Arena in Orland Park, IL. The 2009 **Labor Day Face-Off Invitational** will run from Saturday September 5th thru Monday September 7th, 2009. This year's tournament will consist of up to 12 Teams competing at each level in a divisional alignment. Games will begin the morning of September 5th.

Teams will compete in a four game guarantee divisional format. The top four teams advance to the semifinals. The tournament will conclude with the Championship game on Monday September 7th in the afternoon.

The Arctic Ice Arena is a state of the art facility featuring 3 sheets of ice, a full service pro-shop, concession stand, Original Six Bar and Grill, and second floor private viewing for scouts and coaches along with their own private hospitality room throughout the weekend. It has been recognized as the finest ice hockey facility in the State of Illinois. Entry fee for the 2009 Labor Day Face-Off Invitational is \$1350.00 (USD). Full payment will be due on August 15th, 2009 with a deposit of \$500.00 due with your team's application. Teams not accepted will have their deposit returned. Teams who are accepted but drop out after August 15th will forfeit their deposit. **Teams must use only Official Host Hotels, which will be established within close proximity to the arena. An Official Host Hotel list will be provided. Teams will select the hotel of their choice and book directly with the hotel.**
